Board Meeting – April 6, 2017

Minutes

Present: Joanne D, Doug K., Kerry T., Jessica S., Roger B., Libby Q., Allison H.

Meeting: President Dahlen called the meeting to order at 7:30.

Consent Agenda including:

- Minutes of previous meeting
- Treasurers Report
- Attendance Report

Motioned by Roger Black, Seconded by Allison Hulbert-Bruce and approved by the Board.

Board Discussion:

Ad Hoc Committee next steps: President Joanne Dahlen presented the board with a plan to form an Ad Hoc Committee of club and board members to take up the matter of the previous board discussion concerning a possible change of venue of the weekly club meetings. The as yet unnamed committee will examine the broader issues of club participation including where, when and how often as well as the what events outside the regular club meetings that will qualify for makeup status.

This Yearly, as opposed to Standing, Committee will be formed subsequent to the May Board Meeting, after its formation has been announced at an April club meeting.

Meeting Cancellation Procedures: The Board accepted a procedure for cancelling a regular weekly breakfast meeting for weather-related reasons whenever the Beekmantown Central School District closes or institutes a delayed opening for weather-related reasons. Whenever possible, the President or acting President will call off a regular weekly breakfast meeting the evening before the meeting in order to give Sunrise Club members, venue staff and program speakers and participants greater notice of the cancellation.

Awards Dinner: President J. Dahlen and Libby Quéguiner led a discussion on the date and venue of the annual Awards Dinner. It was suggested we look at Tuesday, June 20, 2017, in lieu of the regular breakfast meeting. Libby Q. was exploring if suitable arrangements could be made with Mooney Bay at a \$35 per head price. A time of 5 p.m. for cocktails and 5:30 for dinner was suggested.

Committee Participation Event: Roger Black outlined a discussion with club members that he would like to see take place at an April or May Assembly. With a goal to rejuvenate and energize club committees for the 2017 - 2018 term, the assembly event would include the participation of the president, president-elect, president nominee, secretary and as many committee chairs as possible. It is hoped this event will evolve into an annual opportunity for committees to meld with the President-elect shortly before everyone's new term begins.

Revitalization of Downtown Plattsburgh: President Joanne D. led a discussion reviewing our previous meeting with Mayor Colin Read at the March board meeting and a subsequent public meeting that she

and Doug K. attended at City Hall.

That meeting included extensive discussion about the proposed Amphitheatre Project where many questions were raised.

There was also a discussion of the proposed STEAM which suggested that project remains in the envisioning process.

Joanne said she would be making further inquiries in the near future to better understand where each of these projects stand.

2017/2018 Draft Budget: There was discussion about the proposed budget for the upcoming year. In general, the board felt it was well along the process of adopting a 2017/2018 budget.

Additional Discussion:

Member requests for Donations at weekly meetings: Roger Black brought up some concerns about the number of requests for donations for outside causes that are circulated at some breakfast meetings. He suggested that it be suggested that members clear the requests with the President prior to the beginning of the meeting. President Dahlen suggested that the collection of donations could be arranged for at the end of the meeting.

Publicizing Events: With the greater number of Rotary-related and even non-Rotary events being scheduled, the board discussed how to better publicize these events to club members. Joanne D. said she will work on creating a PowerPoint presentation of events to run on a rotation basis during the meeting, especially during the beginning of the meeting.

Roger B said he will look into the possibility of embedding a Google Calendar into the Sunrise Club website.

Youth Exchange: Doug Kashorek provided an extensive report on the past and present activities as well as future expectations of the Youth Exchange Committee. He expressed concern that he could personally continue the amount of effort required without additional help, especially in light of his upcoming term as president of the club.

The board agreed changes were needed for the program to continue. Suggestions included:

- Changing and expanding the committee to include committee members taking on separate YE tasks and responsibilities.
- Planning for a periodic "break year" every third or so year where no YE student is sponsored.
- Alternating long-term and short-term YE programs.

The board also recognized the need to expand the entire Youth Programs Committee to better support all the youth programs including RYLA and future programs involving area primary and secondary schools.

Adjournment: Motioned by Roger B., seconded by Jessica S. and approved by the board.
