In President Sue LeBlanc-Durocher's absence, Incoming President Jeff Prescott called the meeting to order and asked if there were any change/corrections to the April Board meeting minutes. On a motion by Eric McDowell and seconded by Jessica Kline, the April meeting minutes were approved. All voted in favor.

Treasure's Report – Jessica Kline presented the draft 2021-2022 budget. This budget needs to be approved prior to July. The recent pizza cooking class raised \$635 for the local Food Shelf. Of this \$635, we aren't sure how much of it was brought in from Noon Rotary. Jessica has budgeted \$1,000 for 2-3 cooking classes in the upcoming year. An expense line of \$1,000 has been added in for Mayor's Cup. The draft budget will be resent to the Finance Committee. Roger and Jeff will attend a Noon Rotary meeting to see if MHAB might work for our meetings and what the costs might be. We don't need to provide a full breakfast. We would need to continue to have a way for members to attend virtually. So would need an iPad and someone dedicated to the technology. We will add this topic to the agenda of May's Club Assembly Meeting.
