## Board Meeting –January 14, 2021

### Minutes

#### **Meeting:**

President LeBlanc-Durocher called the meeting to order and asked if there were any change/corrections to the December Board meeting minutes. On a motion by Eric McDowell and seconded by Roger Black, the December meeting minutes were approved. All voted in favor.

Nominations For New Board Members – Tom LaBombard will present the nominations for new board members at our next meeting. Jessica Kline will resign as Treasurer effective July 1. Michelle Kalil has expressed an interest in becoming the Treasurer. The only problem is that Michelle's contract is a yearly one and there is no guarantee that she will be here beyond October 2021. Jessica would be willing to pick it back up if Michelle has to leave. We will need to get Quickbooks for Michelle to use. The cost would be around \$30. Jessica will bring this request before the Finance Committee for their o.k. The next meeting is scheduled for the 3<sup>rd</sup> Thursday of the month. Sue has reached out to Niki Buck and Thom Lorement, Sr. about their attendance at meetings. Kathy Snow will reach out to Lori Delaney to see why she hasn't been in attendance. As well, Amel Varga's attendance has been hit or miss lately. Allison's attendance has Roger concerned; Libby to check with her.

**Weekly Meetings** – Have we come up with a target date to resume our weekly in person meetings? Noon Rotary started meeting in person but has since stopped. Perkins is still interested in hosting us.
